Shooting Range Rules Waiver
To become an APPROVED MEMBER
To have ACCESS to the Shooting Range

Black Creek Conservation Club's shooting range is a safe, locked, fenced area for *Approved Current Members* who have the only access. Being that the general public cannot gain access, unless accompanied by an APPROVED MEMBER, OR BECOMES AN Approved Member – our shooting range is extremely safe and secure.

- ♦ I have read and understand the "Black Creek Conservation Club Range Rules." I will abide to those rules, and will make sure all of my "visitors and children" will do the same. I am fully accountable for my actions and the actions of my "visitors and children" while on the shooting range of Black Creek Conservation Club. I fully understand that by signing this waiver, it will allow the applicants on my Membership Application, (me, my spouse, and children) the Secure Gate Combination to the "Restricted" Shooting Range. I also fully understand that if I, or my "visitors" or children, do not abide by the rules of the shooting range, I (we) will be asked to leave the Club grounds immediately; and depending on the severity of the incident be brought in from of the Board of Directors of Black Creek Conservation Club. I understand that if found negligent, my Membership could be voided for the remainder of the year or even be banned from membership of any kind in the future.

Black Creek will only release Secure Gate Lock information to those who sign this waiver, becoming an APPROVED Member who has agreed to abide by the By-Laws and Shooting Range Rules of the Club.

- ♦ Also, once you have become an APPROVED Member with the Secure Gate Lock information, it is your right to intervene in unsafe acts by phoning the proper chair persons of the Range, the President of the Club, a board member or Authorities which are listed on the grounds. We all deserve to be safe while having fun sighting in our guns, trap shooting or target practicing. This is a family organization, so it is of the highest importance that our children see EVERYONE taking their place in making SAFETY 1st.
- ♦ Sharing of the Secure Gate Information is also **STRICTLY PROHIBITED**. If anyone wishes to have the Secure Information they too should become a member, just like you have chosen to do.
- ♦ I have read the Black Creek Conservation Club Range Rules. I will fully abide by these rules listed on the Shooting Range Rules sheet provided to me in New Membership Packet and these rules are also posted on the Grounds of Black Creek Conservation Club – 2634 S. Chippewa Rd., Mt. Pleasant, MI.
